The following information will be required when submitting a City of Metter Occupational Tax Registration application:

REQUIRED DOCUMENTS:

- ☐ A completed City of Metter Business Registration Occupational Tax Return Application. *(attached)*
- ☐ A *valid* Georgia State I.D. or Driver's License for the applicant(s).
- □ S.A.V.E. Affidavit (Affidavit Verifying Status) <u>Non-US citizens are required to attach a verifiable document as described at the bottom of the affidavit. (attached)</u>
- □ Private Employer Affidavit (O.C.G.A. 36.60-6) *(attached)*
- ☐ A Federal Tax I.D. number from the Internal Revenue Service will be needed, if applicable (www.irs.gov) The IRS can be reached by phone at 1-800-829-1040.
- ☐ Each person or business profession required to be licensed by the Professional Licensing Board of Georgia or any other Georgia State Department, shall provide a current state licensure at the time of registering a business or before an Occupational Tax Certificate can be issued. Please refer to the state licensing information listed on the back.
- □ Non-profit businesses are required to provide a current valid exemption (501 c 3) letter of determination issued by the IRS.

ADDITIONAL INFORMATION:

LIFE SAFETY INSPECTION

Before opening, every new business is required to have a life safety inspection conducted by the Metter Fire Department. To set up an appointment, call 912-685-6832.

FOOD SERVICE PERMIT

All restaurants, deli's, ice cream parlors/yogurt shops (etc.) must contact Karen Anderson at the *Candler County Health Department* at 912-685-5765. A copy of your Food Service Permit is required before an Occupational Tax Certificate can be issued.

CONVENIENCE STORES/GROCERY STORES, ETC.

All convenience stores, grocery stores, coffee shops, bakeries (etc.) must contact the *Georgia Department of Agriculture* at 404-656-3600. A copy of your state license/permit is required before an Occupational Tax Certificate can be issued.

All Occupational Tax Certificates expire on December 31st of the current year. A 90-day grace period is given to all businesses until March 31st. After March 31st, a ten percent penalty will be added to all outstanding accounts.

BUSINESS SIGNS, CONSTRUCTION & RENOVATION

A sign permit is required for the erection, alteration, or reconstruction of any sign within the City of Metter. Any construction or renovation of the building may also require a building permit prior to any work being done. For more information, please contact City Hall.

NOTE: Licenses and permits are not issued at the time of submittal of application.
