CALL TO ORDER AND WELCOME

Mayor Boyd called the hearing to order and welcomed everyone.

<u>PURPOSE</u>

The purpose of the hearing was to allow public input on the proposed FY 2023 City of Metter budget.

PRESENTATIONS

City Manager Carter Crawford presented the Fiscal Year 2023 Budget Assumptions.

Any budget by definition is a planning document and not every issue will have been determined prior to its preparation and adoption. Therefore, it is necessary to make assumptions and base the budget plan on them. Then, if any circumstance changes, we will know whether it meets the assumptions or not, thereby requiring budget review to determine if any adjustments are needed.

2023 Budget Assumptions are as follows:

- 1. Ad valorem tax millage rate will not increase, but due to the County tax assessor's office recent tax reassessment, City ad valorem taxes will increase.
- 2. No increase in water/sewer rates.
- 3. No sanitation rate increase.
- 4. SPLOST revenues are scheduled to end.
- 5. LOST revenues will be reduced due the required LOST negotiations between the City and the County.
- 6. \$96,551.00 of SPLOST funds will be used retiring capital debt.
- 7. \$75,000.00 will be budgeted for LMIG street improvements.
- 8. \$450,000.00 will be transferred to the general fund from City reserve funds.
- 9. All proprietary funds will be self-supporting.
- 10. The total number of employees will not increase.
- 11. City employees will receive a 2.5% merit increase and qualified employees will receive a one-time lump sum 3% inflation adjustment.
- 12. Employee health insurance will increase by 5%.
- 13. Employee retirement will be 6% of salary.
- 14. The City will contract housing of City prisoners and ad valorem tax collection with Candler County and the County will contract with the City for fire and animal control. County will pay 50% of cost for fire and 60% of costs for animal control.
- 15. The City will closely follow its adopted financial policies.
- 16. The City's fiscal year 2023 Budget will be adopted and accounted for using generally accepted accounting practices.
- 17. The City's fiscal year 2023 Budget is balanced as required by U.S. Federal law.

Budgets are balanced as follows:

General Fund	\$4,650,565.00
Hotel Motel Tax	\$ 96,700.00
Sanitation	\$ 606,100.00
Water & Sewer Revenue	\$3,956,153.00
