# **Ordinance Annexing Property**

Councilwoman Kilcrease made a motion to approve an ordinance annexing 9.631 acres of property owned by the Metter/Candler Airport Authority into the corporate limits of the City of Metter effective the 13<sup>th</sup> day of December 2022. Councilwoman Taylor seconded the motion, and the vote was unanimous.

## **Application for Variance**

Councilman McKie made a motion to approve an application for a variance of the Metter Zoning Ordinance submitted by Mike Collins for property located at 140 Oaktree Road. Councilwoman Kilcrease seconded the motion, and the vote was unanimous.

#### **Request from Metter Tree Board**

Councilman Sikes made a motion to approve a request from the Metter Tree Board to plant a live oak tree in the William "Billy" Trapnell Park in memory of Carvy Snell. Councilwoman Kilcrease seconded the motion, and the vote was unanimous.

## **GMA Lease Agreement**

Councilwoman Taylor made a motion to approve a lease supplement between the City of Metter and the Georgia Municipal Association in the amount of \$109,619.00 for the

purchase of a JCB backhoe and to authorize Mayor Boyd to execute the necessary documents. Councilwoman Kilcrease seconded the motion, and the vote was unanimous.

# DEPARTMENTAL REPORTS

# **CITY MANAGER'S REPORT**

Mr. Crawford reported on the following:

- 1. In January, we will start the process to get certified through the DCA Plan First Program.
- 2. We are in the process of applying for a 3.5-million-dollar loan through the United States Department of Agriculture (USDA) for the construction of the new fire department. This will be for the long-term loan. We will need a construction loan through a local bank. We will pay this off with the money from the USDA loan.
- 3. City finances are good.

## **MAYOR'S REPORT**

Mayor Boyd reported the following:

- 1. The Lighting of Metter went well. It was well attended. Mayor Boyd complimented Mr. Crawford on the new Christmas Tree. He also thanked the city workers and others who helped make it all happen.
- 2. Mayor Boyd informed council that Glennell Eason will be retiring in January. She is a key worker, who will be hard to replace. She has also recently had knee surgery.
- 3. Mayor Boyd thanked the staff for putting together the City Christmas Dinner. The food and venue were great.
- 4. The Industrial Authority is busy looking at several projects.
- 5. Incubator is also busy with about 50 clients, and some are getting ready to graduate out. We have brought in a consultant to help with marketing products. She is the owner of the third largest firm that markets agricultural products. Georgia Tech has also come onboard.

They are also working with a mushroom producer who will be making blocks for other mushroom growers. They have bought 25 acres in the Industrial Park. We are presently trying to work out the water and sewer issues. It is a 21-million-dollar project and will employ 30 people. This will be good paying jobs.

The Welcome Center is having record sales.
