Vendor space is limited. All vendors must be set up by 4:30 p.m. and are responsible for bringing their own tables. Set up time is from 2:30-4:30 p.m. Please sign in at the vendor table when you arrive the day of the event. Electricity must be requested in advance. There is limited availability. You will be assigned a booth space at check in.

Applications are due on Thursday, November 16, 2023, by 4:30 pm with a payment of \$35.00. Food truck vendors are \$75.00 for one food truck space. All proceeds go to the Lighting of Metter and the Metter Welcome Center.

All authorized vendors participating in The Lighting of Metter are independent operators and not partners or joint ventures and shall be individually and severally liable for any loss, personal injury, deaths, and /or any other damages that may occur as a result of the vendor's negligence or that of its employees, agents, and associates. All vendors are required to sign the Hold Harmless Clause included in The Lighting of Metter Vendor Form. All vendors agree to indemnify and save The Lighting of Metter, The City of Metter, and Candler County harmless from any loss, costs, damages, and other expenses including attorney's fees, suffered or incurred by The Lighting of Metter by reason of vendor's negligence or intentional misconduct or that of its employees, agents, and associates; provided that the vendor shall not be liable for nor required to indemnify The Lighting of Metter, The City of Metter, or Candler County for the negligence of any of them or that of their servants, agents, employees or associates. Because no insurance is provided at The Lighting of Metter concerning vendors, each vendor must carry his or her own personal and product liability insurance. Furthermore, vehicle liability insurance is required to cover any damage caused to persons or property by a vendor's vehicle.
